Object: **REGULATION (EC) n°. 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), RoHS Directives and PAH Specifications.**

Dear Customer,

We confirm you that all the products we supply to you are Compliant with Regulation (EC) n°. 1907/2006 (REACH).

As You know, the European Chemical Agency (ECHA) published on 30/06/08 a list of 14 Substances of Very High Concern (SVHC List) that may become subject to authorisation. Many other substances have been continuously added to the list in the past years. These substances have been included in such Candidate List (Annex XIV) in accordance with Article 59 of REACH Regulation and information sharing obligations are provided in Article 33. The aim of Article 33 is to ensure that sufficient information is communicated with articles to allow their safe use. So, as supplier of articles, we have the duty to communicate information on articles containing substances on the candidate list and we may have to forward required information available down the supply chain (Article 33(1)) and to consumers on request (Article 33(2)). Any supplier of an article containing a substance meeting the criteria in Article 57 and identified in accordance with Article 59(1) in a concentration above 0,1% weight by weight (w/w) shall provide the recipient of the article with information including, as a minimum, the name of that substance. Please note that in case of complex articles, the concentration shall be calculated on the weight of the sub-articles (according to the European Court of Justice decision for Case C-106/14).

As regard the new updating of Candidate List dated **23/01/2024** which has been published on the ECHA website:

we inform you that the following articles supplied by Fitt S.p.A.:

- **76523.30625.01265 23485233 NEPT PREM NTSPPLUS FT FR 3/4"25m**

do not contain any SVHC of the Candidate List and phthalate plasticisers in a percentage above 0.1% (w/w) and comply with the requirements and restrictions defined in Annex XVII of REACH.

Moreover, in response to your request, articles above mentioned comply with the requirements of:

- EU Directive 2011/65/EC on the restriction of the use of certain hazardous substances in electrical and electronic equipment (RoHS 2).
- DIRECTIVE (EU) 2015/863 amending Annex II to Directive 2011/65/EU of the European Parliament and of the Council as regards the list of restricted substances (RoHS 3).

Based on the information available, compounds of cadmium, lead, mercury and hexavalent chromium, flame retardants PBB and PBDE including Pentabromodiphenyl Ether (CAS-No. 32534-81-9) and Octabromodiphenyl Ether (CAS-No. 32536-52-0), DEHP, BBP, DBP and DIBP plasticizers are not contained in the articles supplied to you above the concentration limits listed in Annex II of the afore-mentioned Directives.



Furthermore, following the Withdrawal of Great Britain from the European Union, the United Kingdom and Northern Ireland have implemented or modified the local legislation. This communication is intended to provide you with relevant information for the UK market. With reference to the retained version of the EU REACH Regulation under European Union (Withdrawal) Act 2018 (UK REACH) as amended by Statutory Instrument 2019 No. 758, Statutory Instrument 2019 No. 858, Statutory Instrument 2019 No. 1144, Statutory Instrument 2020 No. 1577 and Statutory Instrument 2021 No. 904, we inform you that the articles above-mentioned do not contain any SVHC identified in the UK Candidate List in a percentage above 0.1% (w/w). The applicable Candidate List can be download at <https://www.hse.gov.uk/reach/substance-in-articles-notification.htm>.

Also, we confirm that they comply with the requirements and restrictions defined in Annex XVII of UK REACH. Moreover, FITT's Articles abovementioned comply with the requirements of the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Equipment Regulations 2012 as amended by Statutory Instrument 2020 No. 1647.

Eventually, the articles above-mentioned comply with the specifications provided by AfPS GS 2019: 01 PAK – Category 2:

- “Testing and assessment of polycyclic aromatic hydrocarbons (PAHs) in the course of awarding the GS mark - Specification pursuant to article 21(1) no. 3 of the Product Safety Act (ProdSG)”.
- “Materials not covered by category 1, with foreseeable skin contact for longer than 30 seconds (long-term skin contact) or repeated short-term skin contact”.
